**AMENDMENT TO**  
**AGREEMENT FOR PROFESSIONAL SERVICES BETWEEN**  
**THE CITY OF NEW ORLEANS**  
**AND**  
**UDDO, BEATMANN & CODE/BASILE J. UDDO**

**THIS AGREEMENT** is made and entered into as of the 1<sup>st</sup> day of January 2011, by and between the City of New Orleans, herein represented by Arnie Fielkow, President of the Council of the City of New Orleans (hereinafter referred to as "City"), and the law firm of Uddo, Beatmann & Code/Basile J. Uddo (herein represented by "Contractor")

**WITNESSETH**

**WHEREAS**, the City Council desires to engage qualified and professional service consultants to provide cable/telecommunications consulting services to the City Council; and

**WHEREAS**, pursuant to Motion M-09-621 and the terms of the Request for Qualifications the Council is authorized to renew and extend its existing 2010 contract with the firm of Uddo Beatmann & Code/Basile J. Uddo for the calendar year 2011; and

**WHEREAS**, by Motion M-11-38 adopted on February 3, 2011, the President of the Council is hereby authorized to sign a contract amendment with the firm of Uddo, Beatmann & Code/Basile J. Uddo extending the contract through 2011 and increasing the maximum compensation under such contract by One Hundred Sixty Thousand Dollars (\$160,000.00);  
now, therefore

**WHEREAS**, all parties to the agreements dated January 1, 2010 desire to amend the agreement and have the necessary authority to do so.

**THEREFORE, IT IS HEREBY AGREED:**



To increase the maximum compensation payable under the terms of this agreement by "\$160,000.00" thereby increasing the amount on line 23 of page 3 of 9 and lines 1 and 3 of page 4 of 9 of the Agreement dated January 1, 2010 for the firm of Uddo Beatmann & Code/Basile J. Uddo. The maximum compensation for all services including professional hours and expenses shall not exceed Three Hundred Twenty Thousand Dollars (\$320,000.00). If there are any necessary and ordinary expenses attached to the work of the firm of Uddo Beatmann & Code/Basile J. Uddo these expenses shall be reimbursable by the City but the total amount of such expenses, in addition to the fees shall not exceed Three Hundred Twenty Thousand Dollars (\$320,000.00).
2. To change the termination date of the agreement by deleting the date, "December 31, 2010" on line 12 of page 7 of 9 and inserting in lieu thereof the date "December 31, 2011".


