**AMENDMENT**

**TO AGREEMENT FOR PROFESSIONAL SERVICES**

**BETWEEN**

**THE CITY OF NEW ORLEANS**

**AND**

**THE ESTOPINAL GROUP**

THIS AGREEMENT made this 1st day of July 2014 by and between the City of New Orleans, herein represented by Stacy S. Head, Council President (hereinafter referred to as "the City"), and The Estopinal Group, (hereinafter referred to as "Contractor").

**WITNESSETH**

**WHEREAS**, pursuant to Motion M-11-495, the City Council approved the recommendation of the Competitive Selection Committee that The Estopinal Group be retained to provide communication services to the City Council; and

**WHEREAS**, the City entered into an agreement dated January 1, 2012, with the Estopinal Group for the purpose of providing communication services to the City Council during 2012 for up to \$125,000.00; and

**WHEREAS**, by Motion M-12-474, the City Council approved an extension to this contract for 2013; and

**WHEREAS**, by Motion M-13-463, the City Council approved an extension to this contract for six months, through June 30, 2014; and

**WHEREAS**, the Council desires to authorize a contract amendment and extension in the contract with The Estopinal Group for the purpose of providing communications services to the City Council; and

**WHEREAS**, by Motion M-14-200, the President of the Council is hereby authorized to sign a contract amendment with The Estopinal Group extending the contract through December

1 31, 2014; and

2 WHEREAS, all parties to the agreement dated January 1, 2012 desire to amend the  
3 agreement and have the necessary authority to do so;

4 THEREFORE IT IS HEREBY AGREED:

5 1. To increase the maximum compensation payable under the terms of this agreement by  
6 \$67,500.00 thereby increasing the amount of the agreement dated January 1, 2012 for  
7 The Estopinal Group. The maximum compensation for all services including hours  
8 and expenses shall not exceed Three Hundred and Eighty Thousand Dollars  
9 (\$380,000.00)

10 2. To change the termination date of the agreement by deleting the date,  
11 "June 30, 2914", on line 12 of page 7 of 10 and inserting in lieu thereof the date  
12 "December 31, 2014".

13 Both parties to this amendment hereby reaffirm the validity of all other provisions of the  
14 original agreement dated January 1, 2012, save the above and foregoing changes.
