AMENDMENT TO
AGREEMENT FOR PROFESSIONAL SERVICES
BETWEEN
THE CITY OF NEW ORLEANS
AND
JEFFERY S. GULIN

THIS AGREEMENT is made and entered into as of the 1st day of January 2014, by and between the City of New Orleans, herein represented by Jacquelyn B. Clarkson, President of the Council (hereinafter referred to as "City"), acting on behalf of the City Council, and Jeffery S. Gulin (hereinafter sometimes referred to as "Contractor").

WITNESSETH

WHEREAS, to address the complex legal and technical issues necessary to properly meet its responsibility, the Council requires the services of a hearing officer to supervise ongoing proceedings in the Council's Utility Dockets and to that end, conducted a competitive selection process in accordance with Council Rule 45 to address this requirement on a long term basis; and

WHEREAS, pursuant to Motions M-13-18 and the terms of the Request For Qualifications that was issued on October 19, 2012, the Council is authorized to renew and extend its existing contract with its hearing officer, Jeffrey S. Gulin; and

WHEREAS, the Council desires to authorize appropriate contract amendment(s) and extension with Jeffrey S. Gulin to assist in meeting the Council's regulatory responsibility to the City and its ratepayers; now therefore

WHEREAS, pursuant to Motion M-13-440, adopted on November 21, 2013, the President of the Council is hereby authorized to sign a contract amendment with Jeffery S. Gulin extending the contract through 2014 and increasing the maximum compensation under such contract by Thirty Thousand Dollars (\$30,000.00).

THEREFORE, IT IS HEREBY AGREED:

1. To increase the maximum compensation payable under the terms of this agreement by "\$30,000.00" thereby increasing the amount on lines 16 and 17 of page 3 of 12 of the Agreement dated January 1, 2013 for Jeffrey S. Gulin. The maximum compensation for all services including professional hours and expenses shall not exceed Sixty Thousand Dollars (\$60,000.00). If there are any necessary and ordinary expenses attached to the work of the Jeffrey S. Gulin these expenses shall be reimbursable by the City but the total amount of such expenses, in addition to the fees shall not exceed Sixty Thousand Dollars (\$60,000.00).

1 2. To change the termination date of the agreement by deleting the date, December
2 31, 2013", on line 9 of page 9 of 12 and inserting in lieu thereof, the date
3 December 31, 2014".
