Uddo/Uddo Beatman and Code to assist in meeting the Council's responsibility to the City and its

citizens; now, therefore

BE IT MOVED BY THE COUNCIL OF THE CITY OF NEW ORLEANS, that the President of the Council is hereby requested and authorized to sign a contract amendment with the firm of Basile J.
