

1 **WHEREAS**, all parties to the agreement dated June 1, 2010 desire to amend the
2 agreement and have the necessary authority to do so.

3 **THEREFORE, IT IS HEREBY AGREED:**

4 1. To change the termination date of the agreement by deleting the date, “July 1, 2010”,
5 on line 11 of page 8 of 20 and inserting in lieu thereof, the date “December 31, 2010”.

6 2. To delete the lines 13 through 17 of page 8 of 20 in their entirety and insert in lieu
7 thereof the following:


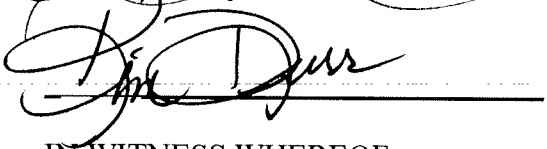
8 “Section 2. Renewal. This agreement cannot be renewed past December 31, 2010.”

3 for the Estopinal Group.


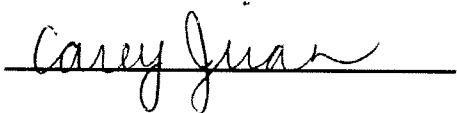

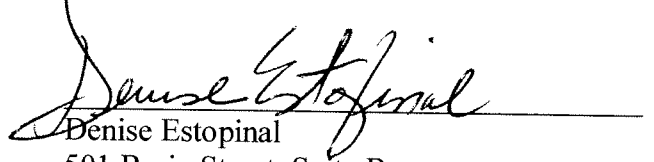

WHEREAS, by Motion M-07-464, after competitive selection, the City Council authorized retention of The Estopinal Group (TEG) to provide communications consultant services to the City Council; and

WHEREAS, pursuant to Motion M-07-464, terms of the Request for Proposals issued April 5, 2007, and the December 20, 2007 contract with TEG, the Council is authorized to renew and extend its existing contract with The Estopinal Group to provide communications consulting services to the City Council; and

WHEREAS, the Council experienced extraordinary needs for communications services during the transition from the previous Council, and during the planning and execution of inaugural activities, photography and website updates, which needs necessitate an increase to the contract; and

WHEREAS, the Council has determined that it wishes to continue the communications services of TEG through the end of 2010; now, therefore

BE IT MOVED BY THE COUNCIL OF THE CITY OF NEW ORLEANS, That the President of the Council is hereby requested and authorized to sign a contract amendment with The Estopinal Group extending the December 20, 2007 contract, as amended by the agreements dated October 24, 2008, and the agreement dated January 1, 2009, as amended by agreement dated September 18, 2009, and the agreement dated January 1, 2010, extending said agreement through December 31, 2010, and setting the maximum compensation under such contract to up to One Hundred Fifty Three thousand Dollars (\$153,000.00).

BE IT FURTHER MOVED BY THE COUNCIL OF THE CITY OF NEW ORLEANS, That contract amendment (s) shall be circulated in accordance with normal process and the City Council Rules.
