6	THIS AGREEMENT is made and entered into as of the 1st day of January 2011, by and
7	between the City of New Orleans, herein represented by Arnie Fielkow, President of the Council
8	of the City of New Orleans (hereinafter referred to as "City"), and the law firm of Aaron, P.L.C.
9	(herein represented by "William D. Aaron, Jr.").
10	WITNESSETH
11	WHEREAS, the City Council desires to engage qualified and professional service
12	consultants to provide cable/telecommunications consulting services to the City Council; and
13	WHEREAS, pursuant to Motion M-09-621 and the terms of the Request for
14	Qualifications the Council is authorized to renew and extend its existing 2010 contract with the
15	firm of Aaron, P.L.C. for the calendar year 2011; and
16	WHEREAS, by Motion M-11-36 adopted on February 3, 2011, the President of the
17	Council is hereby authorized to sign a contract amendment with the firm of Aaron, P.L.C.
18	extending the contract through 2011 and increasing the maximum compensation under such
19	contract by Three Hundred Thousand Dollars (\$300,000.00); now, therefore
20	WHEREAS, all parties to the agreements dated January 1, 2010 desire to amend the
21	agreement and have the necessary authority to do so.

THEREFORE, IT IS HEREBY AGREED:

- 1. To increase the maximum compensation payable under the terms of this agreement by "\$300,000.00" thereby increasing the amount on lines 2 and 5 of page 4 of 9 of the Agreement dated January 1, 2010 for the firm of Aaron P.L.C.

 The maximum compensation for all services including professional hours and expenses shall not exceed Six Hundred Thousand Dollars (\$600,000.00). If there are any necessary and ordinary expenses attached to the work of the firm of Aaron, P.L.C. these expenses shall be reimbursable by the City but the total amount of such expenses, in addition to the fees shall not exceed Six Hundred Thousand Dollars (\$600,000.00).
- 2. To change the termination date of the agreement by deleting the date, "December 31, 2010 on line 15 of page 7 of 9 and inserting in lieu thereof the date "December 31, 2011.
