8	and between the Council of the City of New Orleans, represented by Arnie Fielkow, President of			
9	the Council (hereinafter referred to as "City") acting on behalf of the City Council and the firm of			
10	London Economics International LLC (hereinafter sometimes referred to as "Contractor").			
11	WITNESSETH			
12	WHEREAS, on April 2, 2009 the Council adopted Resolution R-09-136 in the matter of			
13	Entergy New Orleans' ("ENO") July 31, 2008 application for a change in electric and gas rates			
14	which among other things, established the process to govern the principles to be used in Council			
15	Docket No. UD-08-02 in the evaluation, design, implementation, delivery measurement			
16	implementation of cost recovery and incentives, savings goals associated with the Energy Sm.			
17	Plan to be considered for final Council approval in said Docket; and			
18	WHEREAS, by Motion M-10-108, after competitive selection, the City Council			
19	approved the recommendation of the Council Utility Committee to retain the firm London			
20	Economics International LLC to provide the services of an Independent Monitor to			
21	independently oversee all aspects of Entergy New Orleans in the Selection of a Third Party			
22	Administrator by Entergy New Orleans, and			

1	WHEREAS, the Council entered into a contract with London Economics international				
2	LLC to provide these services; and				
3	WHEREAS, by Motion M-11-59 the President of the Council is hereby authorized to				
4	sign a contract amendment with London Economics International LLC increasing the amount of				
5	compensation to London Economics International LLC.; now, therefore				
6	WHEREAS, all parties to the agreements dated April 14, 2010 desire to amend the				
7	agreement and have the necessary authority to do so.				
8	THEREFORE, IT IS HEREBY AGREED:				
9	1. To increase the terms of this agreement by \$45,000.00 thereby increasing the				
10	amount on line 6 of page 6 of 13 of the Agreement dated April 14, 2010 for the				
11	firm of London Economics International LLC. The compensation to be paid to				
12	the firm of London Economics International LLC. for such services shall not				
13	exceed \$125,000.00. If there are any necessary and ordinary expenses attached to				
14	the work of the firm of London Economics International LLC., these expenses in				
15	addition to any fees outlined above, shall be reimbursable by the City.
