AGREEMENT FOR PROFESSIONAL SERVICES

BETWEEN

THE COUNCIL OF THE CITY OF NEW ORLEANS

AND

OXFORD ACOUSTICS, INC.

THIS AGREEMENT made this _______ day of September 2013, by and between the Council of the City of New Orleans, herein represented by Jacquelyn Brechtel Clarkson, Council President (hereinafter referred to as "the City"), and Oxford Acoustics, Inc., (hereinafter referred to as "Contractor").

RECITALS

WHEREAS, pursuant to Motion M-12-02 the Council authorized the Council President to sign a contract with Oxford Acoustics, Inc. to provide professional services for the collection and analysis of data related to sound levels in various parts of the City, as well as an analysis of the City's noise ordinance; and

WHEREAS, it is necessary to extend and renew this contract; and

WHEREAS, all parties to the agreements dated January 5, 2012 desire to amend the agreement and have the necessary authority to do so; and

WHEREAS, by Motion M-13-323 adopted on September 12, 2013, the President of the Council is hereby authorized to sign a contract amendment with Oxford Acoustics, Inc. extending the contract through 2013;

THEREFORE, IT IS HEREBY AGREED:

- 1. To change the termination date of the agreement by deleting the date, "April 30, 2012" on line 28 of page 5 of 6 and inserting in lieu thereof the date "December 31, 2013".
- 2. To change and expand the scope of services to include the additional services outlined in Attachment "A1".
- 3. To increase the maximum compensation payable under the terms of this agreement by "\$2392.00" thereby increasing the amount on lines 18 and 29 of page 2 of 6 and line 1 of page 3 of 6 of the Agreement dated January 5, 2012 for the firm of Oxford Acoustics, Inc. The maximum compensation for all services including professional hours and expenses shall not exceed Seventeen Thousand Two Hundred Forty-Two Dollars (\$17,242.00). If there are any necessary and ordinary expenses attached to the work of the firm of Oxford Acoustics, Inc. these expenses shall be reimbursable by the City but the total amount of such expenses, in addition to the fees shall not exceed Seventeen Thousand Two Hundred Forty-Two Dollars (\$17,242.00).
- 4. To provide that the compensation under this amendment, for work performed after September 12, 2013, shall be made in accordance with the following hourly rate schedule:

Standard Investigation and Reporting \$125.00/hour

Expert Investigation and Report for Legal Matters \$187.50/hour

Expert Testimony/Deposition \$250.00/hour

Payment under this agreement shall be made pursuant to detailed monthly invoices submitted by the firm, subject to review and approval by the City for payment.

5. To provide that all work described in Attachment "A1" will be completed by October 31, 2013.
