7	THIS AGREEMENT is made and entered into as of the day of Servin 2014,		
8	by and between the City of New Orleans, herein represented by Stacy Head, President of the		
9	Council (hereinafter referred to as "City"), acting on behalf of the City Council, and Jeffery		
10	S. Gulin (hereinafter sometimes referred to as "Contractor").		
11	WITNESSETH		
12	WHEREAS, to address the complex legal and technical issues necessary to properly		
13	meet its responsibility, the Council requires the services of a hearing officer to supervise		
14	ongoing proceedings in the Council's Utility Dockets; and		
15	WHEREAS, by Motion M-14-396 adopted on September 18, 2014, the President of		
16	the Council is hereby authorized to sign a contract amendment with Jeffrey Gulin increasing		
17	the maximum compensation under such contract by Forty Thousand Dollars (\$40,000.00);		
18	and		
19	WHEREAS, all parties to the agreement dated January 1, 2014 desire to amend the		
20	agreement and have the necessary authority to do so.		
21	THEREFORE, IT IS HEREBY AGREED:		
22	1. To increase the maximum compensation payable under the terms of this		
23	agreement by "\$40,000.00" thereby increasing the amount on lines 11, 14 and		
24	15 of page 2 of 3 of the Amendment to Agreement dated January 1, 2014 for		

1	Jeffrey S. Gulin. The maximum compensation for all services including
2	professional hours and expenses shall not exceed One Hundred Thousand
3	Dollars (\$100,000.00). If there are any necessary and ordinary expenses
4	attached to the work of the Jeffrey S. Gulin these expenses shall be
5	reimbursable by the City but the total amount of such expenses, in addition to
6	the fees shall not exceed One Hundred Thousand Dollars (\$100,000.00). The
7	total authorization for the year 2014 shall be Seventy Thousand Dollars
8	(\$70,000.00).
