## **AGREEMENT FOR PROFESSIONAL SERVICES** 1 2 BETWEEN THE CITY OF NEW ORLEANS 3 4 AND 5 **CURRY & FRIEND, PLC** 6 THIS AGREEMENT made this 1st day of January, 2015, by and between the City of 7 8 New Orleans, herein represented by Stacy S. Head, Council President (hereinafter referred to as "the City"), and CURRY & FRIEND, PLC, represented by Guy C. Curry, 9 10 Owner and Managing Partner (hereinafter referred to as "Contractor"). 11 12 WITNESSETH WHEREAS, pursuant to Motion M-14-71, the City Council authorized the 13 President to enter into a contract with Curry & Friend, PLC to provide Special Counsel 14 15 service to the City Council; and 16 WHEREAS, the City entered into an agreement dated March 1, 2014, with Curry 17 & Friend, PLC for the purpose of providing Special Counsel services to the City Council during 2014 for up to \$50,000.00; and 18 WHEREAS, the Council desires to authorize a contract amendment and 19 20 extension to the contract with Curry & Friend, PLC for the purpose of providing Special 21 Counsel Services to the City Council; and 22 WHEREAS, by Motion M-14-472, adopted by the Council on November 6, 2014, the Council authorized and requested the Council President to sign a contract 23 24 amendment with Curry & Friend, PLC extending the contract through 2015; and 25 WHEREAS, all parties to the agreement dated March 1, 2014 desire to amend 26 the agreement and have the necessary authority to do so; 27 THEREFORE IT IS HEREBY AGREED: 1. To change the termination date of the agreement by deleting the date, 28 "December 31, 2014", on line 1 of page 7 of 16 and inserting in lieu thereof the 29 30 date "December 31, 2015"; and

2. To change the termination date of the agreement by deleting the date "December

1	31, 2014", on line 2 of page 11 of 16, and inserting in lieu thereof the date
2	"December 31, 2015"; and
3	3. To change the compensation provided in the agreement by deleting the figure
4	"\$50,000.00", in line 8 of page 6 of 16, and inserting in lieu thereof the figure
5	"\$50,000.00 for the year 2015".

7	Both parties to this amendment hereby reaffirm the validity of all other provisions of the
8	original agreement dated March 1, 2014, save the above and foregoing changes.
