7	THIS AGREEMENT is made and entered into as of the 1st day of January 2015, by
8	and between the City of New Orleans, herein represented by Stacy Head, President of the
9	Council (hereinafter referred to as "City"), acting on behalf of the City Council, and Jeffery
10	S. Gulin (hereinafter sometimes referred to as "Contractor").
11	WITNESSETH
12	WHEREAS, to address the complex legal and technical issues necessary to properly
13	meet its responsibility, the Council requires the services of a hearing officer to supervise
14	ongoing proceedings in the Council's Utility Dockets and to that end, conducted a
15	competitive selection process in accordance with Council Rule 45 to address this requirement
16	on a long term basis; and
L7	WHEREAS, pursuant to Motions M-13-18 and the terms of the Request For
18	Qualifications that was issued on October 19, 2012, the Council is authorized to renew and
L9	extend its existing contract with its hearing officer, Jeffrey S. Gulin; and
20	WHEREAS, the Council desires to authorize appropriate contract amendment(s) and
21	extension with Jeffrey S. Gulin to assist in meeting the Council's regulatory responsibility to
22	the City and its ratepayers; now therefore

- WHEREAS, pursuant to Motion M-14-508, adopted on November 20, 2014, the
- 2 President of the Council is hereby authorized to sign a contract amendment with Jeffery S.
- 3 Gulin extending the contract through 2015 and increasing the maximum compensation under
- 4 such contact by Forty Thousand Dollars (\$40,000.00).

THEREFORE, IT IS HEREBY AGREED:

1. To increase the maximum compensation payable under the terms of this agreement by "\$40,000.00" thereby increasing the amount on lines 16 and 17 of page 3 of 12 of the Agreement dated January 1, 2013 for Jeffrey S. Gulin. The maximum compensation for all services including professional hours and expenses shall not exceed One Hundred Forty Thousand Dollars (\$140,000.00). If there are any necessary and ordinary expenses attached to the work of the Jeffrey S. Gulin these expenses shall be reimbursable by the City but the total amount of such expenses, in addition to the fees shall not exceed One Hundred Forty Thousand Dollars (\$140,000.00).
