1 **AGREEMENT FOR PROFESSIONAL SERVICES**

7 THIS AGREEMENT made this 1st day of January, 2015, by and between the City of
8 New Orleans, herein represented by Stacy S. Head, Council President (hereinafter
9 referred to as "the City"), and DON A. ROUZAN & ASSOCIATES, LLC, represented by
10 Don A. Rouzan, Owner and Managing Member (hereinafter referred to as "Contractor").

12 **W I T N E S S E T H**

14 **WHEREAS**, pursuant to Motion M-14-71, the City Council authorized the
15 President to enter into a contract with Don A. Rouzan & Associates, LLC to provide
16 Special Counsel service to the City Council; and
17

18 **WHEREAS**, the City entered into an agreement dated March 1, 2014, with Don
19 A. Rouzan & Associates, LLC for the purpose of providing Special Counsel services to
20 the City Council during 2014 for up to \$50,000.00; and

22 **WHEREAS**, the Council desires to authorize a contract amendment and
23 extension to the contract with Don A. Rouzan & Associates, LLC for the purpose of
24 providing Special Counsel Services to the City Council; and

26 **WHEREAS**, by Motion M-14-472, adopted by the Council on November 6, 2014,
27 the Council authorized and requested the Council President to sign a contract
28 amendment with Don A. Rouzan & Associates, LLC extending the contract through
29 2015; and

31 **WHEREAS**, all parties to the agreement dated March 1, 2014 desire to amend
the agreement and have the necessary authority to do so;

1 **THEREFORE IT IS HEREBY AGREED:**

- 2 1. To change the termination date of the agreement by deleting the date,
3 "December 31, 2014", on line 5 of page 7 of 16 and inserting in lieu thereof the
4 date "December 31, 2015"; and
- 5 2. To change the termination date of the agreement by deleting the date "December
6 31, 2014", on line 6 of page 11 of 16, and inserting in lieu thereof the date
7 "December 31, 2015"; and
- 8 3. To change the compensation provided in the agreement by deleting the figure
9 "\$50,000.00", in line 12 of page 6 of 16, and inserting in lieu thereof the figure
10 "\$50,000.00 for the year 2015"; and
- 11 4. To change the address for Don A. Rouzan & Associates, LLC by deleting the
12 address, "2555 Ursulines Avenue, Suite B, New Orleans, Louisiana 70119" in
13 lines 12 and 13 of page 12 of 16, and inserting in lieu thereof the address "1010
14 Common Street, Suite 2410, New Orleans, Louisiana 70112".

16 Both parties to this amendment hereby reaffirm the validity of all other provisions of the
17 original agreement dated March 1, 2014, save the above and foregoing changes.
