WHEREAS, Council Rule 45 establishes a competitive selection process for the selection of professional services to the City Council; and

WHEREAS, on August 4, 2011, the City Council adopted Motion M-11-340, determining that professional services were required to provide a turn-key, comprehensive scalable and flexible agenda preparation and document management system plus an internet video streaming and meetings management solution for New Orleans and directing its staff to issue a Request for Proposal (RFP) to begin the competitive selection process established by Council Rule 45; and

WHEREAS, a RFP for these professional services for the City of New Orleans was issued on August 15, 2011; and

WHEREAS, pursuant to Motion M-12-201, after competitive selection, the City Council authorized the retention of Granicus, Inc. ("Granicus") to provide these professional services for the City of New Orleans for an initial period from June 30, 2012 until December 31, 2012, thereafter subject to renewal on an annual basis for a total period of up to five years; and;

WHEREAS, pursuant to Motion M-13-68, the City Council authorized an extension of this contract from January 1, 2013 until December 31, 2013; and

WHEREAS, pursuant to Motion M-14-67, the City Council authorized an extension of this contract from January 1, 2014 until December 31, 2014; and

WHEREAS, pursuant to Motion M-15-136, the City Council authorized an extension of this contract from January 1, 2015 until December 31, 2015; and

WHEREAS, pursuant to motion M-16-130, the City Council authorized an extension of this contract from January 1, 2016 until December 31, 2016; and

WHEREAS, the Council desires to authorize a contract extension with Granicus, Inc. to renew the contract for an additional annual period from January 1, 2017 until December 31, 2017 to provide for the continuation of these services; now, therefore

BE IT MOVED BY THE COUNCIL OF THE CITY OF NEW ORLEANS, That the President of the Council is hereby requested and authorized to sign a contract extension with Granicus, Inc. for an additional annual period from January 1, 2017 until December 31, 2017.

BE IT FURTHER MOVED BY THE COUNCIL OF THE CITY OF NEW ORLEANS, That contract amendment(s) shall be circulated in accordance with normal process and the City Council Rules.
