Hrapmann, Hogan & Maher and Bruno & Tervalon, have performed those respective audits in
recent years;

WHEREAS, Rule 45of the Council's Rules and Regulations permits the renewal or extension of existing contracts when continuity of service is essential; NOW THEREFORE

BE IT MOVED BY THE COUNCIL OF THE CITY OF NEW ORLEANS, That the President of the Council is hereby authorized to sign a contract amendment with Postlethwaite & Netterville, Luther C. Speight & Co., Duplantier, Hrapmann, Hogan & Maher and Bruno & Tervalon for extensions to their existing contracts to conduct the CAFR, audits of the Municipal Employee Retirement System, Police and Firefighter Pension Systems and the Single Audit for FY 2014.

BE IT FURTHER MOVED, That such contract shall be properly routed in accordance with normal process and the City Council Rules.

BE IT FURTHER MOVED BY THE COUNCIL OF THE CITY OF NEW ORLEANS, That the Council authorizes its staff to issue a new RFP to conduct the CAFR, audits of the Municipal Employee Retirement System, Police and Firefighter Pension Systems and the Single Audit for FY 2015, as well as to conduct audits for the following four fiscal years assuming mutual satisfaction.
