**Brief:**

Requesting that the Mayor, pursuant to the powers conferred by La. R.S. 29:727(F)(1) and by the December 13, 2019 Declaration of Emergency, suspend the applicability of the applicability of administrative deadlines imposed by the City Code, City's Comprehensive Zoning Ordinance, or any other rule, regulation, or law requiring the Council to formally act or respond.
