Improper conduct, as specified in this subsection, shall consist of actions which violate the penal provisions of this Code or other penal ordinances of the city.
- c) New Orleans City Code Section 10-157 (a)(12)—provides to wit: Violation at the premises of any of the provisions of section 26-111 et seq., $\underline{30-651}$ et seq., $\underline{66-136}$ et seq., $\underline{66-241}$ et seq., and chapters 82 and 138 or any other health or sanitation ordinance of the city or the state sanitary code.
