Copies of the request must be simultaneously provided to the Council Chief of Staff and Executive Counsel.
- 2. A request for Council approval must be accompanied by the copy of the proposed agreement, together with a contract summary on a form prepared by Council central staff, highlighting the purpose, term, and amount of the contract, along with any key substantive details. For contracts resulting from a competitive selection process, the request for Council approval must include copies of the responses received and considered pursuant to that competitive selection process and the corresponding score sheets for each of the evaluation committee members.
- 3. The Clerk of Council, in consultation with the Council Chief of Staff, shall refer contract execution requests to the Council committee whose purview includes the stated purpose of the contract or, in all other cases, to the Governmental Affairs Committee.

- 4. When circumstances warrant expedited consideration, a contract may be considered by the appropriate committee before the request for execution is formally received through the Council's adoption of the Consent Agenda.
- 5. If a majority of the committee members votes to recommend approval and execution of the contract, a "by request" motion approving same shall appear on the agenda of the next Council meeting. All committee members voting in favor of the motion shall be listed as sponsors.
- 6. Contracts governed by this Rule may not be modified by a motion, but the Council may grant the President the authority to withhold signature until specified amendments to a proposed contract are agreed to by the requesting department and the other signatories to the contract.
- 7. Except as otherwise expressly provided in the motion approving the execution, execution of a contract approved by motion of the Council under this Rule shall impose a ministerial, non-discretionary duty on the Council President.
