



Ordinances

1. **Ordinance Cal. No.** - [32734](#), [32735](#) (Introduced 8-8-19) by Councilmember Brossett (By Request)

These ordinances amend the 2019 Operating Budget of Revenues and Expenditures, appropriating \$80,400 (Other Operating) in Federal grant funds from Intergovernmental Transfers to the Department of Health, Emergency Medical Services for the 2016 Port Security Grant Program for education training.

2. **Ordinance Cal. No.** - [32736](#) (Introduced 8-8-19) by Councilmember Brossett (By Request)

This ordinance amends the 2019 Operating Budget of Expenditures transferring \$50,000 (from Personal Services to Other Operating) within the Department of Health for management study of health related issues.

3. **Ordinance Cal. No.** - [32746](#), [32747](#), [32747 FN](#) (Introduced 8-22-19) by Councilmembers Brossett, Giarrusso, Moreno, Nguyen and Gisleson Palmer (By Request)

These ordinances amend the 2019 Operating Budget of Revenues and Expenditures, appropriating \$63,222 (Personal Services) in Aviation Board funds from Intergovernmental Transfers to the Department of Finance, Bureau of Purchasing for an Analyst in Finance to administer and process purchase orders via the online BRASS system, assist vendors and NOAB end users and various other procurement and bid issues involving the NOAB.

4. **Ordinance Cal. No.** - [32748](#), [32749](#), [32749 FN](#) (Introduced 8-22-19) by Councilmember Brossett (By Request)

These ordinances amend the 2019 Operating Budget of Revenues and Expenditures, transferring \$950,000 from Intergovernmental Transfers (Fund Balance) to the Chief Administrative Office (CAO) and the New Orleans Recreation Development Commission for critical 2019 expenditures. The funds are allocated as follows: CAO - \$400,000 (other Operating) and NORDC - \$550,000 (other operating).

5. **Ordinance Cal. No.** - [32766](#), [32767](#) (Introduced 9-19-19) by Councilmember Brossett (By Request)

These ordinances amend the 2019 Operating Budget of Revenues and Expenditures, transferring \$996,810 from Intergovernmental Transfers (Fund 699) to the Office of Workforce Development for Workforce Innovation and Opportunity Act Title 1B formula funds for the Adult, Dislocated Worker, and Youth Program (State Grants/ FUND DOL – Other Operating).

6. **Ordinance Cal. No.** - [32768](#), [32769](#) (Introduced 9-19-19) by Councilmember Brossett (By Request)

These ordinances amend the 2019 Operating Budget of Revenues and Expenditures, transferring \$1,300,000 from Intergovernmental Transfers (Fund 699) to the Chief Administrative Office, Law Department, and the New Orleans Recreation Development Commission for critical 2019 expenditures. The funds are allocated as follows: CAO - \$400,000 (Other Operating); Law Department - \$350,000 (Other Operating), and NORDC - \$550,000 (Other Operating).

7. **Ordinance Cal. No.** - [32771](#) (Introduced 9-19-19) by Councilmember Brossett (By Request)

This ordinance amends the 2019 Capital Budget, appropriating \$321,596 in Special Permit Fees for the use of the Department of Public Works for Citywide Drainage Improvements.
