

Ordinances

1. Ordinance Cal. No. - 32928, 32929 (Introduced 3/5/20) by Councilmembers Brossett, Giarrusso, Moreno, Nguyen and Gisleson Palmer (By Request)

These ordinances amend the 2020 Operating Budget of Revenues and Expenditures, transferring \$119,519 of Environmental Disaster Mitigation Funds from the Intergovernmental Transfers Operating Budget (Intergovernmental Transfers) to the Mayor's Office, Homeland Security Environmental Disaster Mitigation Revolving Fund (Other Operating - \$119,519) for the purpose of increasing the disaster resilience of the local seafood industry.

2. Ordinance Cal. No. - 32952, 32953 (Introduced 5/7/20) by Councilmembers Brossett, Giarrusso, Moreno, Nguyen and Gisleson Palmer (By Request)

These ordinances amend the 2020 Operating Budget of Revenues and Expenditures, appropriating \$804,765 from Intergovernmental Transfers to the Department of Property Management (Other Operating - \$804,765) for the upkeep, care, and improvement of Gallier Hall.

3. Ordinance Cal. No. 32956 (Introduced 5/7/20) by Councilmembers Brossett (By Request)

This ordinance amends the 2020 Capital Budget, de-appropriating \$15,855,748 from various projects which are deemed to have been completed or cancelled and any unexpended but previously appropriated funds shall remain in the originally appropriated source.

To adjust department de-appropriation and appropriation amounts as indicated by Amendment to Ordinance Calendar NO. 32,956.

4. Ordinance Cal. No. 32957 (Introduced 5/7/20) by Councilmembers Brossett (By Request)

This ordinance amends the 2020 Capital Budget, appropriating \$1,413,611 of Hazard Mitigation Funds to the Department of Public Works for the Oak Park Drainage Upgrades/Green Infrastructure project.

5. Ordinance Cal. No. - 32958, 32959 (Introduced 5/7/20)by Councilmembers Brossett (By Request)

These ordinances amend the 2020 Operating Budget of Revenues and Expenditures, appropriating \$47,927 of State Grant Funds from Intergovernmental Transfers and \$86,045 of the Louisiana Commission on Law Enforcement (LLE) Fund from (personal services - \$86,045) to the LLE Fund

- Department of Police (other operating \$133,972) for the Victim Assistance and Advocates in the District grant programs.
- **6.** Ordinance Cal. No. 32967, 32971 (Introduced 5/21/20) by Councilmember Brossett (By Request)

These ordinances amend the 2020 Operating Budget of Revenues and Expenditures, appropriating \$1,834,156 HUD HOME Investment funds from Intergovernmental Transfers to the Office of Community Development.

7. Ordinance Cal. No. – 32968 (Introduced 5/21/20) by Councilmember Brossett (By Request)

This ordinance amends the 2020 Operating Budget of Expenditures, transferring \$40,961 HUD grant funds from Personal Services (code - 100) to Other Operating (code - 200) in the Office of Community Development.

8. Ordinance Cal. No. – 32969, 32970 (Introduced 5/21/20) by Councilmembers Brossett (By Request)

These ordinances amend the 2020 Operating Budget of Revenues and Expenditures, appropriating \$240,590 of HUD (HOME & ESG) Grant Funds from Intergovernmental Transfers to the Office of Community Development – HOME NOFA (other operating - \$188,375) and ESG (Other Operating - \$52,215).

9. Ordinance Cal. No. – 32972, 32973 (Introduced 5/21/20) by Councilmember Brossett (By Request)

These ordinances amend the 2020 Operating Budget of Revenues and Expenditures, appropriating \$3,825,9647 from Intergovernmental Transfers to the Economic Development Fund (personal services - \$440,201, other operating - \$3,385,763) to establish a budget.

10. Ordinance Cal. No. – 32974, 32975 (Introduced 5/21/20) by Councilmember Brossett (By Request)

These ordinances amend the 2020 Operating Budget of Revenues and Expenditures, appropriating \$1,500,000 from Intergovernmental Transfers to the Neighborhood Housing Improvement Fund - Other Operating.

11. Ordinance Cal. No. – 32977, 32978 (Introduced 5/21/20) by Councilmember Brossett (By Request)

These ordinances amend the 2020 Operating Budget of Revenues and Expenditures, appropriating \$35,990,957 of HUD Funds from Intergovernmental Transfers to the Housing and Urban Development Fund – Office of Community Development various programs – \$25,608,124 (personal services \$469,741, other operating - \$25,138,383) and State & Local Foundation Grants – Office of Community Development (Other Operating - \$10,382,833).
