Friends,

The three most common complaints our office receives now involve sanitation, roadwork, and streetlights. Within the past year, those engagements have only become more frequent. In this special newsletter, I'm going to touch on updates presented to City Council within the past 2 weeks.

SANITATION UPDATE

The Administration is currently advocating for once-weekly garbage pickup service. The Department of Sanitation spoke to the Council's Public Works Committee a couple of weeks ago, updating us on the current state of collections and contracts. However, these new contracts increase the costs of sanitation service without increasing the services themselves. There are remaining questions on why the costs of these contracts is still rising, as covered in <u>The Advocate</u>. Therefore, this Council does not currently plan to vote on these new contracts.

Service Area 1, which covers the rest of District A, is no stranger to missed collections. Sanitation issued a performance letter to Richard's Disposal (RDI) in July, but service disruption continues. This is a quality-of-life issue and, obviously, needs to be remedied immediately.

Service Area 1 Missed Collection Complaints



 As of August 15th, Richard's Disposal (RDI) missed collection complaints for 2022 have already surpassed elevated 2021 levels.

ROADWORK

The Department of Public Works (DPW) explained the current state of roadwork across the city at our August Public Works committee meeting. Almost every single neighborhood in District A is affected by stalled work, with some projects extended more than six months. The earlier DPW policy prioritized street repair quantity over quality. The Administration is trying to fix those issues now on the back end, but delays nonetheless continue. Below is merely an illustrative and certainly not an exhaustive summary of roadwork issues, just in District A. There are also multiple pain points in Lakeview and Mid-City, and we're asking for updates similar to those shown below.

The Marleyville/Fountainbleau project has been extended by 237 days, simply to add 2 blocks to the project. That's nearly 3 years of continuously undrivable

streets with \$3.5 million in add-ons.

Here is another example of delayed work. Taking 305 days to fix 18 blocks is a long time and deeply impacts residents and businesses in this compact area.

My office is currently trying to schedule a DPW/Roadworks District A community event in October. The goal is to provide residents direct, clear answers to questions about street repairs and other DPW work in their neighborhood. More information will be provided as we finalize this event.

STREETLIGHTS

DPW also discussed its plans, processes, and timelines for repair at the August Public Works Committee. Here is the City's prioritization plan for streetlights:

- Tier 1: 600 ft proximity to Population Centers (such as schools, parks, grocery stores and senior centers)
- Tier 2: 1200 ft from Population Centers
- Tier 3: Remaining 311 cases

We have been regularly reporting streetlight issues since Hurricane Ida. Our office maintains a list of streetlight issues and their status separate and apart from 311. You can see the entire list at this link. Each incident has been reported to DPW, and we've asked them to provide timelines for those repairs. Maintenance crews are expected to make 80 repairs a day, with complete light restoration within 60 days.
