amend the Agreement as follows: NOW THEREFORE, for good and valuable consideration, the City and the Contractor

A. *Extension*. In accordance with Article/Section V of the Agreement, the term is extended for 1 additional year from the Effective Date through February 28, 2026.

B. Compensation.

The compensation described in Article/Section IV of the Agreement is increased by \$75,167.62 to a total amount not to exceed \$416,962.65. The City will pay the Contractor in accordance with the following rate:
