A **RESOLUTION** approving the issuance of not exceeding Seventy-Five Million Dollars (\$75,000,000) of City of New Orleans Sewerage Service Revenue Bonds.

WHEREAS, under the provisions of Part III, Chapter 9, Title 33 of the Louisiana Revised Statutes of 1950, as amended (the "Act"), the Sewerage and Water Board of New Orleans (the "Board") has the power to issue sewerage service revenue bonds in the name of the City, and pursuant to the Act, the Board has adopted Resolution R-197-2019 giving preliminary approval to the issuance of not exceeding \$75,000,000 of City of New Orleans Sewerage Service Revenue Bonds (the "Sewerage Bonds"); and

WHEREAS, the Sewerage Bonds are to be administered by the Board of Liquidation, City Debt (the "Board of Liquidation"), and pursuant to Part XIV, Chapter 4, Title 39 of the Louisiana Revised Statue of 1950, as amended, the Board of Liquidation has adopted a resolution giving preliminary approval to the Sewerage Bonds; and

WHEREAS, the Sewerage Bonds are proposed to be issued for the purpose of (i) constructing extensions, improvements, enlargements, betterments, alterations, renewals and replacements to the sewerage system of the City, (ii) funding a debt service reserve fund and other reserve funds, if required, and (iii) paying costs of issuance of the Sewerage Bonds; and

WHEREAS, an executed copy of each of the aforesaid resolutions has been furnished to this City Council; and

WHEREAS, it is the desire of this Council to the approve the issuance of the Sewerage

Bonds so that the Board and Board of Liquidation may proceed with the issuance and sale of

thereof; NOW, THEREFORE

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NEW ORLEANS, That

the issuance of the Sewerage Bonds in the amount of not exceeding Seventy-Five Million Dollars

(\$75,000,000) for the purposes set forth in the preamble hereto is hereby approved. The Sewerage

Bonds shall mature not later than thirty (30) years from the date thereof, bear interest at a rate of

not exceeding six percent (6%) per annum, and be secured, equally with the City's outstanding (i)

Sewerage Service Revenue Bonds, Series 2011, (ii) Sewerage Service Revenue and Refunding

Bonds, Series 2014, (iii) Sewerage Service Revenue Bonds, Series 2015, and (iv) Sewerage

Service Revenue Bonds, Series 2019, by the pledge of revenues derived from sewerage service

charges in the City, for purposes relating to the sewerage system of the City.
